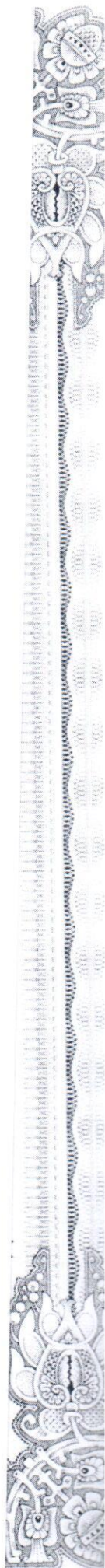

- maintaining accounts of the customers (residents and non-residents) in foreign currency and non-resident customers in the national currency of Ukraine;
- maintaining correspondent accounts of banks (residents and non-residents) in foreign currency;
- maintaining correspondent accounts of banks (non-residents) in the national currency of Ukraine;
- opening correspondent accounts with the authorized banks of Ukraine in foreign currency and related transactions on them;

- attracting and placing foreign currency on the foreign exchange market of Ukraine;
